FOR THE ELECTION OF EXECUTIVE OFFICERS**

Since the closure of Alma College, the role of the International Alumnae Association has morphed into a committee overseeing the annual reunion. Over the years, it has become more and more difficult to convince alumnae to stand for office. In an effort to manage the need to recruit executive officers every two years, we are proposing a change to the bylaws to revise the officers' terms to four years. Please review and vote on the proposed bylaw change and return this form.

- I support revising the bylaws from a two-year term for executive officers to a four-year term. There must be an election held in June 2018 for a new term from 2018 - 2022.
- I support keeping the bylaws as currently written. An election will be held in June 2018 for a new term from 2018-2020.
